## **BOAT INSURANCE**

The Locaboat Holidays fleet is insured against all accidental damage to the boat or to third parties caused by the use of the boat (e.g. collision with another boat or structure).

#### **SECURITY DEPOSIT**

However, as with all insurance, there is a deductible, which must be deposited as a financial guarantee on the day of departure, in the form of a **DEPOSIT**. The amount varies from €1,200 to €2,000, depending on the boat. This deposit will be fully refunded on your return\* if no damage has been reported or observed on board by our on-site teams. However, in the event of damage, the captain remains financially responsible and will have to pay the cost of repairs, with a maximum limit set by the amount of the deposit.

#### DEPOSIT REDEMPTION - (Please note that the Serenity Package includes deposit redemption.)

The **DEPOSIT REDEMPTION** is a non-refundable sum paid by the renter on the day of departure. The amount may vary from €110 to €200, depending on the type of boat rented and the length of stay. It exempts the captain from repair costs in the event of damage. (Excluding conditions of exclusion). However, unlike a deposit, the deposit buy-back is non-refundable. Please note that you will still be asked to pay **a reduced\* deposit of €500**, even if you have subscribed to the bond buy-back, to prevent any damage incurred under insurance exclusions.

\* In Italy, the deposit is maintained for 15 days after your return.

On the day of departure, you'll have the choice of depositing a security deposit for the boat, or taking out a bond redemption (with a reduced security deposit). In both cases, you will be asked to provide a credit card imprint as a guarantee.

Whichever option you choose, in the event of an accident, you'll need to fill in a claim form and inform your departure base as soon as the event occurs.

Please note that renters, their personal belongings and their own liability are not covered by the boat's insurance.

### **INSURANCE EXCLUSIONS**

**IMPORTANT**! The following items, known as "Exclusions

The following items, referred to as "Exclusions", are not covered under any circumstances by the boat's insurance, nor by the deposit or deposit buyback. In the event of damage to the boat, caused to a third party or a structure within the scope of one of these exclusions, the hirer remains financially responsible and will have to pay the amount of the damage, whatever its amount, and without ceiling:

#### Serious breaches such as:

- Breach of navigation rules
- Driving while intoxicated, under the influence of narcotics or substances affecting consciousness or ability to react

- Misrepresentation
- Deliberate damage to the boat, or damage unrelated to an accident
- Damage, breakage or loss of small items or on-board equipment (inventory), unrelated to an accident
- Damage to the bimini or convertible (canvas and/or roll bar)
- Intervention following clogged toilets by the crew
- Loss, theft or damage to rental bicycles
- Damage and costs related to grounding,
- Boat abandonment costs
- Poor barbecue cleaning
